## **Dhimurru Terms and Conditions**



# PLEASE READ AND – WITH RESPECT TO YOLNGU CUSTODIANS, THE ENVIRONMENT AND YOUR OWN SAFETY – COMPLY.

#### Permit holders agree:

- To carry your permit with you (digitally as a screenshot or in hard copy) always.
- Permits only to be booked a maximum of 6 months in advance unless advised.
- Child Permits 16 yrs and under, date of birth and surname must be selected when purchasing.
- That your permit may be revoked, cancelled or suspended at any time in accordance with the Aboriginal Land Act 1978 (NT) if you or any other person named on your permit breaches these terms and conditions or does not follow the law.
- That you enter Aboriginal land your own risk and you agree that Dhimurru, the Northern Land Council and the relevant Land Trust have no liability of any kind in respect of death, injury, loss or damage of an kind and however arising, during or as a result of a visit to this land.
- That you consent to Dhimurru sharing your personal information with third parties, your personal information collected for the purposes of administering this permit and permit system.
- Dhimurru Aboriginal Corporation reserves the right to amend, cancel, or revoke any bookings or permits in accordance with Northern Territory Indigenous Protected Area (IPA) laws and regulations, without prior notice.
- That this permit is not transferable and is applicable to the persons, vehicles and dates specified on this permit.
- That permit holders will have an up to date COVID vaccination status, will have no signs
  or symptons of COVID immediately before entry into Dhimurru Recreation Areas, in the
  7 days immediately before entry that you have not been in a foreign country, and you
  are not entering to engage in an illegal activity.

### Only go where you are permitted to go

- Travel on approved roads and do not divert or use other private roads to access recreation areas.
- Drive on defined tracks only and don't drive on the beach, except at those locations agree to as part of this permit.
- Observe all signs and comply with all directions of Dhimurru/NLC/Police.
- If you come to a locked gate, do not pass through, turn back.
- Do not photograph, interfere with, enter or remain on sacred sites except in accordance with this permit and the Northern Territory Sacred Sites Act 1984 (NT).
- Not access the cliff face, or top of the cliff, of Banambarrnga (Rainbow cliff) as it is a sacred site.

#### Stay safe and respect others

- Not interfere with the activities of Aboriginal people or other persons in the area and do not enter any buildings, dwellings, living areas or camps without the consent of the owner or occupier.
- Take reasonable precautions to ensure transport, machinery and camping gear are soil, weed, seed and pest free prior to entry of Aboriginal land.
- Ensure their motor vehicles are registered, in satisfactory condition and that they carry reasonable spare parts, food, fuel and water.
- Be responsible for extracting your motor vehicle/s if they become stuck or malfunction.
- Not park vehicles or trailers on boat ramp areas.

#### Leave no trace

- Only camp in designated camp sites.
- Remove, and dispose of waste thoughtfully, including burying toilet waste at least 15cm deep and 100m from campsites and creeks.
- Do not disturb the environment, including wildlife, vegetation, water and soils.
- Only remove flora (including wood) from those locations designated by Dhimurru's signage.
- Ensure your dog is always under effective control and do not bring other domestic animals into the recreation areas.

#### Refrain from all prohibited activities

- Don't ride an unregistered motorbike, trailbike, off-road vehicle, ATV or quad.
- Don't hunt or shoot/discharge any firearms or weapons.
- Don't use drones, unless expressly authorised by the permit.
- Don't bring caravans onto the Dhimurru Designated Recreation Area.

### Obtain other permits and licences as required

- Do not conduct commercial tour operations without a sub-licence from Dhimurru.
- Photographs, audio or video recording for commercial purposes, must only be undertaken with a permit from the Northern Land Council/Nhulunbuy Corporation.
- Follow the laws regulating the consumption of alcohol in East Arnhem Land and have the right alcohol permits in place.
- Be in possession of a valid licence for the vehicle being operated.
- Not conduct trade or work activity unless expressly authorised by the permit.
- Get your fishing permits from the Northern Land Council, this permit does not authorise fishing and/or hunting or the use of boats in "closed seas". Fishing permitted along the banks of Dhimurru recreational areas unless stated.

PLEASE NOTE: Each campsite is charged at a minimum rate of 2x adults.

#### **Cancellations**

The system will now remove a booking from the grid immediately if it is cancelled using the online cancellation button. An email will automatically be generated and sent to you confirming the cancellation. Please email **permits@dhimurru.com.au** to request your refund.

We ask that if you do not intend to use the site that you cancel the booking to enable others to utilise it. Camping permits are transferable and can be transferred to others, with notice to Dhimurru Front office by emailing: **permits@dhimurru.com.au**.

#### **Refund Policy**

#### Campsite bookings under a 12 month Visitor Access Permit

- 1. Campsite bookings will be refunded 100% of the total price (apart from booking and credit card fees) if bookings are cancelled no less than 48hours prior to the date of stay.
- 2. 100% refund if the recreation area has been closed by Dhimurru.

## Campsite bookings made under a Visitor Access Permit of one month or less, cancellations by you:

- 1. Campsite bookings cancelled 48hours before the date of the Visitor Access permit will be refunded 100% (except for booking fees and credit fees).
- 2. Campsite bookings will not be refunded if cancelled less than 48hours from the date of stay.
- 3. 100% refund, if the recreation area has been closed by Dhimurru or an event that prohibits the permit holders from accessing the Region, such as road closures or border restrictions, related to COVID restrictions. All cancellations by you, must be via the Cancel button in the online permit booking system. Refunds will be considered according to the policy and money refunded within one month of the date of cancellation. Refund requests must be sent directly to **permits@dhimurru.com.au**
- 4. Please allow up to 2 weeks to process refunds.

### **Extra Campers**

There is an **Extra Camper** button at the top of the buy permits page that will enable you to book visitors on your campsite booking for additional nights when they are **NOT** staying the entire duration of your stay. It is not automatically added to the entire booking. Please make sure you add campers for **ALL** nights they will be camping.
